Rules of the game
"Play with the Nord Pas-de-Calais"

Article 1 : Organization

Le Comité Départemental du Tourisme du Pas-de-Calais, Route de la trésorerie- 62126 WIMILLE – organises the game, the name of which is « Play with the Nord Pas-de-Calais» from 13 mai to 20 juin 2008.

Article II : Participation

The participation to this free game and with no obligation to buy is open to every physical adult person domiciled in metropolitan France / Europe, having access to internet and a valid e-mail address. Concerning the minor persons, the game is run under the responsibility of a legal representative, able to justify his parental authority. The participation is unique per home (same name, same postal address, same e-mail address). The participation is strictly nominative and in no way a player can participate under several usernames or on the behalf of other players. Any uncompleted inscription form, or one in any shape other than the allowed one, will be considered as null.

Article III : Modes of participation

The participants have to authorise any investigation concerning their identity and coordinates (mail and/or internet address). Article VI : Registration of Copyright

The rules can be modified at any time by an endorsement by the organizer, respecting the announced conditions, and published by an online announcement on the game website. The endorsement is registered at the SCP Carlini-Montel-Simeone, associated bailiffs, depository for the rules before its publication. Article VII : Reimbursement of the game expenses

Any participant can ask for a reimbursement of his expenses corresponding to the time spent playing from a fixed telephone line, France Telecom tariff, on a basis of a 3mn low tariff connexion. The request of reimbursement must be sent by mail, to the game address (article VI), coming with the bank account number and a letter mentioning the date and time of the connexion. The stamp charges incurred by the participant will be reimbursed upon a simple request, on the basis of regular postage rate "letter" in force. Only one reimbursement request by registered participant and by envelope (same name, same address) can be accepted. The uncompleted requests will not be considered.

Considering the present state of techniques and services, several Internet providers offer a free or inclusive Internet connexion to Internet users, it is expressly agreed that any access to the website of the game which has been done on a free or inclusive basis (so as cable connexion, ADSL of special link) will not lead to any reimbursement, as that the subscription to the Internet provider's services is in this case contracted by the Internet user for general Internet use, and that the fact of connection and participation to the game does not generate any additional expenses or outlays.

Article VIII : Connexion and use

The participation implies prior knowledge and acceptance by the participant of the features and the limits of Internet the lack of protection of certain data against possible misappropriation and the risks of being contaminated by certain possible computer viruses circulating in the network. *Le Comité Départemental du Tourisme du Pas-de-Calais* cannot be held liable in case of incident linked to the possible defective functioning of the computer, malfunctions of the Internet network, of the telephone line or any other technical connexion, as well as for the delivery of forms to the wrong or incomplete address.

Article IX : Disputes and responsibilities

The participation to this game implies prior unreserved acceptance of the rules in its whole. Any inexact or false declaration, any fraud will lead to the disqualification of the participant. *Le Comité Départemental du Tourisme du Pas-de-Calais* will solely rule any dispute related to the game according to its rule and in agreement with the SCP Carlini-Montel-Simeone, associated bailiffs. No phone or written demand concerning the interpretation of the present rule application, mechanism or playing conditions, as well as the list of winners, will be answered. *Le Comité Départemental du Tourisme du Pas-de-Calais* reserves the right, if required by the circumstances, to listen, to extend, to modify or to annul the present game, as per the article VI. It cannot be held liable in this case.

Article X : Presentation of the prizes
